Ukraine Report Presented to European Parliament and Polish Senate

The CASE report "Prospects for EU-Ukraine relations" has garnered much interest among EU parliamentarians and officials involved in policy decisions on Europe's 'Eastern neighborhood.' The main findings of the report were recently presented at two mini-hearings of the European Parliament and at a session of the Polish Senate (opposite photo).



"The presentations come at a very appropriate time, as Ukraine and the EC are just beginning negotiations on an enhanced trade agreement," says Malgorzata Jakubiak, one of the co-editors of the report. Jakubiak, along with co-authors Vitaliy Vavryschuk and Dmytro Boyarchuk of CASE Ukraine, recently presented the report's main findings during a joint session of the Foreign Relations Committee and the Committee on EU relations at the Polish Senate. Earlier this month the team presented at a mini-hearing of the European Parliament's Committee on International Trade in Brussels as well as a session of the Baltic Intergroup of the European Parliament in Strasbourg. The report has also been presented to academic audiences in Berlin (hosted by DIW Berlin - German Institute for Economic Research) and Kyiv (hosted by CASE Ukraine). CASE Economists Suggest EU Integration as Potential Model for Yemen

A team of CASE economists recently returned from Sana'a where they participated in a discussion on the future development of Yemen organized by the German Technical Cooperation (GTZ). Discussants from Yemen's Ministry of Planning and International Cooperation and from other key government agencies agreed that it was crucial that Yemen be allowed to integrate




into the Gulf Cooperation Council (GCC) by 2015. CASE experts offered the country's policymakers a feasible roadmap for the GCC integration, while they argued that substantial gains to Yemen would be possible only if GCC integration process is used to anchor a strong domestic reforms agenda.

"The seminar offered useful ideas that would help Yemen to make a clear road map that achieves economic integration between Yemen and the GCC countries in accordance with a joint Yemeni-Gulf." assessed Dr. Mohammed al-Hawri, Deputy Minister of Planning and International Cooperation.

One year of ENEPO Project Complete

CASE is leading a three year, 11-team consortium in a specific - targeted research project within the EU's Sixth Framework Program, which analyzes various aspects of the EU's relations with its eastern neighbors (EU Eastern Neighborhood: Economic Potential and Future Development). As the first year of this project comes to a close, we can already see the first results of the research.



A working paper entitled "The Evolution of EU policies towards its CIS neighbours" has been written by Prof. Margot Light of the London School of Economics. A team led by Irina Sinitsina of CASE has

prepared the first draft of a paper on the "Analysis of various dimensions of the existing development gap between the CIS and selected EU countries." A working paper on "Concepts and definitions of institutional development (harmonization) and methodology of measuring them" has been prepared by Anna Kolesnichenko of CASE Ukraine. Alina Kudina of CASE Ukraine has also prepared a working paper on portofolio investement flows. Upcoming Seminar: Lieber to Speak on Energy, Policy, Economy

Warsaw, June 12 at 15:00 at Warsaw School of Economics

Join us for the next BRE-CASE seminar with special guest Professor Robert Lieber who will discuss energy policy, incorporating economic, political, resource and security dimensions. Dr. Lieber will also speak about US-European energy cooperation within the broader context of US-European relations. Dr. Lieber is a Professor



of Government and International Affairs at Georgetown University, and is an authority on American foreign policy. He received his Ph.D. at Harvard and has taught at Harvard, Oxford and the University of California-Davis. In the policy realm, he has been a foreign policy advisor in several presidential campaigns and consultant to the State Department and for National Intelligence Estimates. Dr. Lieber is author or editor of fourteen books on international relations and U.S. foreign policy, the latest being "The American Era: Power and Strategy for the 21st Century" (Cambridge University Press, 2005, 2007). Joining Dr. Lieber in the panel discussion on June 12th will be Professor Jan Popczyk of Politechnika Śląska who will be speaking on technological innovation and Dr. Tadeusz Syryjczyk who will discuss the interaction between consumers, the market, and the state. The discussion will be moderated by Dr. Andrzej Cylwik, president of CASE-Advisors.

Polish Economic Outlook 1/2007



The latest edition of PEO rates 2006 as a year in which economic growth exceeded expectations, reaching the highest

yearly rate since 1997. The outlook for the Polish economy looks positive in the short and medium terms. Forecasts show GDP growth will remain high (above 6%) in 2007, largely due to strong domestic demand, though it is expected to slow by 2008. Inflation remained among the EU's lowest in 2006, yet upward pressures were already visible in the first quarter of 2007. The authors of the report comment on rapidly rising levels of employment and wages, the improvement in the fiscal balance and the continued surge in exports. The report includes a special section devoted to Poland's "Euro Readiness" in comparison to other new member states, which shows that the Polish economy seems capable of fulfilling the Maastricht criteria, with 2012 looking like the the most likely target date.
